Membership of the Organization

- Since the thirtieth regular session of the Assembly in November/December 2017, the Republic of Armenia and the Republic of Nauru have deposited instruments of acceptance to the Convention on the International Maritime Organization with the Secretary-General of the United Nations, on 19 January 2018 and 14 May 2018, respectively. The membership of the Organization therefore now stands at 174. There has been no change in the number of Associate Members, which remains at three.
- In August 2019, the Federated States of Micronesia and the Islamic Republic of Afghanistan expressed interest in joining the Organization and were provided with the relevant information. Since the two States are already Members of the United Nations, they may, pursuant to Article 5 of the IMO Convention, become Members of the Organization by depositing instruments of acceptance to the Convention with the Secretary-General of the United Nations, in accordance with Article 76.
- 3 Any further developments regarding the status of the Convention and membership of the Organization will be reported to the Council and the Assembly, as appropriate. A list of Members of the Organization, together with its Associate Members, as
